

In an attempt to decrease expenses and to increase needed revenue, AAUW CA members are being asked to vote for the following proposals listed below. This voting takes place on-line from April 21 to May 11. The proposals are:

- To increase AAUW CA dues by \$4, from \$16 to \$20, effective July 1, 2014.
- To amend the AAUW CA bylaws to reduce the number of directors from 16 to 12, effective July 1, 2013.

More information about the proposals including a "How To Vote" video can be found on the AAUW CA website. Declining membership and rising costs have necessitated this request from the State for a dues increase, the first one in eight years. If you have any questions about this process or are without computer access, do contact us. Please show your support with your vote.

We definitely are living in a time of change! Recent current events point to the ongoing changes in our lives from technology to church leadership. Maybe you noticed on the front page of this publication, or saw it on the website, or read about it in the publication, *Inside AAUW*, that for the fourth time in our 131 year history AAUW has changed its logo. The new logo was designed to keep pace with communication formats while reflecting our purpose. Check it out!

You may know that Congress passed the Violence Against Women Act (VAWA) on February 28th. This outcome had been doubtful, but women made their voices heard and their influence helped propel Congress to act. President Obama then signed the Act into law in early March.

Congratulations, everyone! Once again the voices of women brought about change!



Science and Math Camp for Girls

(Quoted from the Tech Trek Website. See http://aauw-techtrek.org/)

Tech Trek is a science and math camp designed to develop interest, excitement, and self-confidence in young women who will enter eighth grade in the fall. It



features hands-on activities in math, science, and related fields. All sleeping, eating, instructional, and recreational facilities are

located on a university campus where camps are held.

Where do we find our campers?

All girls attend Tech Trek camps on scholarships provided by AAUW California branch members, working with participating public middle schools in their area. Seventh grade science and/or math teachers at these

schools recommend camper candidates who must then pass through an extensive qualification process that



includes an application, an essay, and a personal interview. Camp curriculum is targeted specifically at girls entering 8th grade.

AAUW LAF Express

On the recommendation of the LAF Committee, the AAUW Board of Directors voted to contribute funds to seven ongoing LAF cases:

Cioca v. Rumsfeld, Klay v. Panetta, and Hoffman v.
Panetta — \$15,000

LeBlanc v. Trustees of Indiana University — \$6,500

For four years, AAUW has supported three lawsuits against Feather River Community College in California. The plaintiffs are former staff members of the institution who allege sex discrimination and retaliation for complaining about sex discrimination in violation of Title IX of the Education Amendments of 1972. In 2007, there was a hearing before the California State Personnel Board. In August 2009, the SPB judge ruled in favor of all three plaintiffs, but in 2010, the full SPB rejected the judge's decision, and the plaintiffs' lawyer appealed. AAUW continues to support
