# National Women's History Alliance "39 Years of Writing Women Back into History"

HISTORY TRIVIA QUESTIONS: What famous Suffragist spoke at the Martinez Opera House during the unsuccessful 1896 suffrage campaign? What early Martinez resident chaired the second Women's Suffrage meeting in upstate New York in 1848?

We are very fortunate to have Molly Murphy MacGregor, co-founder and Executive Director of the National Women's History Alliance, as our guest speaker in April. For 38 years she and other women have been working to ensure that the contributions of women to our nation's history and its success are known and honored by everyone. Now the organization is recognized as an important advocate for studying and recognizing the incredible contributions of women in our country from its beginning.

It is now the centennial year(s) of women obtaining the right to vote -- year(s) because the 19<sup>th</sup> Amendment passed both the House and Senate in 1919 to be sent out for ratification by three-fourths of the states. That was achieved when Tennessee passed it in 1920.

That makes a double good excuse for a celebration. The National Women's History Alliance, headquartered in Santa Rosa, is one of the leaders in the effort underway to make sure that the centennial is honored as it should be and that awareness of the contributions of women to our history are properly and permanently noted. Already NWHA is preparing not only for national celebrations but also for local events. One such is to have local groups such as ours identify the graves of local women who were instrumental in the fight for the vote. We have that information from the 2011 suffrage centennial here in Alhambra Cemetery and other locations. How about a little grave decoration project in our area this year?

Their first success years ago was lobbying Congress to designate March as Women's History Month. NWHA then worked to provide information and training for educators, community organizations and parents on women's contributions to US history. The most recent NWHA success was influencing a Congressional Commission to study the possibility of a museum of American Women's History. In November 2016 the Commission reported to the President and Congress that women's history is integral to the American story and the Smithsonian Institution is the natural place to honor women's contributions to this country. The President and Congress agreed by taking a first step....creating the American Women's History Initiative at the Smithsonian. There were 90 million social media hits in the first 10 days of a marketing campaign, #BecauseOfHerStory.

Ms MacGregor will talk about the work of the NWHA, its goals and the importance of all of us supporting awareness of the contributions of women to our history locally and nationally. We can also think about whether we might organize a little project to honor the Pleasant Hill and Martinez women who worked so hard in 1896 (unsuccessfully) and 1911 (successfully). We know who many of them are! Bring guests and students who would be interested.



PUBLIC POLICY Lita Gloor-Little

March is Women's History Month: in 2020 we will have had the vote for 100 years, AAUW worked hard to get this for us. Below are other lobbying efforts that your dues (part of which goes to National AAUW) helps to create for all women. From the State Chapters here are just a few of the things they are working on.

#### **Battle Over Title IX Heats Up at the State Level**

In November, the Department of Education issued a proposed rule that would undermine the critical civil rights protections of Title IX. In response, over 100,000 comments were submitted regarding the changes, including ones from AAUW and 6,143 AAUW members and supporters from all 50 states opposing the harmful proposal. States are also offering their own responses. Many are scrambling to understand how the proposed regulations would impact current state laws, and some are working to strengthen their existing legal framework. With the support of AAUW of CA, California state Senator Hannah-Beth Jackson (D) introduced a bill outlining procedures that schools would have to follow when dealing with sexual harassment and assault claims. Last year, the Hawaii legislature passed a law to create a state version of Title IX, thanks in part to the advocacy of AAUW of HI members. While the report required by that law is delayed, the state plans to continue to strengthen its provisions in the coming years. Unfortunately, other states, such as Missouri and North Carolina, are attempting to further curtail student rights and protections. AAUW members are fighting back, with AAUW of MO members in particular working hard to stop harmful legislation in their state. All these efforts are important – both to proactively offer good solutions and set the agenda, and reactively respond to problematic offered legislation.

#### More Momentum in 2019 for Passage of the ERA

The Equal Rights Amendment (ERA) to the U.S. Constitution would guarantee constitutional equality between men and women — a concept a <u>majority</u> of Americans agree is necessary. First proposed in 1923, the <u>ERA</u> was ratified by 35 of the necessary 38 states by 1977. However, Congress imposed a deadline to complete ratification by 1982. In 2017 and 2018, <u>Nevada</u> and <u>Illinois</u> became the 36th and 37th states, respectively, to ratify the ERA. Now several states are striving to be the 38th. A particularly robust campaign is underway in Virginia where <u>AAUW of Virginia</u> advocates are leading the charge. If Virginia, or another state, ratifies the amendment <u>further action</u> from Congress would be necessary to complete the process.

Meanwhile, other states are working to add similar protections to their state constitutions. In January, with the support of AAUW of Delaware members, <u>Delaware</u> lawmakers amended their state constitution to include: "Equality of rights under the law shall not be denied or abridged on account of sex." A similar measure is moving forward in the Minnesota legislature.

#### At National Level:

It's official! One of AAUW's top federal legislative priorities – the Paycheck Fairness Act – will be brought for a vote on the House floor as soon as the week of March 25! In anticipation of this major event, we have been ramping up our advocacy since the very first day of this historic Congress. AAUW worked behind the scenes on the House hearing and committee process, Lobby Corps visited hundreds of offices to make sure they have the information they need before the vote, and our staff spoke on panels, at rallies and met with key Congressional offices along with Lilly Ledbetter to garner additional support this important bill. For the last push before the vote, we are looking to our member leaders to hold indistrict meetings and our activists to write to their representatives (starting with "One Thing You Must Do" below) to make it clear that passing the Paycheck Fairness Act is a national priority. This is an all hands on deck moment, and we could not be more excited! Thanks to you, all this hard work will mean that we will be celebrating passage of the Paycheck Fairness Act for this year's Equal Pay Day.

#### Lawsuit Victory Requires Companies to Report Pay Data by Gender, Race

In an important victory on Monday, a federal district court judge in D.C. <u>ruled</u> that the government acted illegally when it stopped the Equal Employment Opportunity Commission (EEOC) from collecting pay data by sex, race and ethnicity from large companies. The government must now move forward with a <u>requirement</u> that employers report compensation information to the EEOC by demographic information and job category. The Trump Administration <u>halted the pay data collection</u> in August 2017 in response to opponents who felt it created a costly and unfair burden on employers. Subsequently, three advocacy groups <u>filed</u> a lawsuit challenging the move. AAUW has long advocated for pay data collection so that employers and enforcement agencies are better able to analyze and act on pay disparities. With this federal pay data collection moving forward, employers and enforcement agencies can better develop solutions to close gender and race pay gaps.

The House of Representatives this week took steps to advance a number of AAUW's <u>priority issues</u>, including combatting workplace harassment, guaranteeing paid leave, raising the minimum wage and preventing violence against women.

On Tuesday, legislators <u>introduced</u> the Ending the Monopoly of Power Over Workplace Harassment through Education and Reporting (EMPOWER) Act. This <u>AAUW-endorsed</u> legislation would address workplace harassment by making it easier and safer for people to speak out and harder for employers to avoid accountability. Also on Tuesday, AAUW SVP Deborah J. Vagins was invited to <u>speak</u> at the press conference for the <u>introduction</u> of the Federal Employee Paid Leave Act (FEPLA), which would provide 12 weeks of paid leave for federal employees. Paid leave was also addressed Thursday at a House Ways and Means Committee <u>hearing</u> on the challenges faced by working families. Members of Congress and witnesses spoke about the importance of passing the <u>FAMILY Act</u>, which would provide paid family and medical leave for all employees. On Wednesday, the House Education and Labor Committee <u>approved</u> the Raise the Wage Act out of committee, <u>defeating</u> several harmful amendments and sending a strong bill to gradually increase the minimum wage to the House floor. And on Thursday, the House Judiciary Committee held a <u>hearing</u> on the reauthorization of the Violence Against Women Act (VAWA). AAUW is excited to see progress on these important issues and pieces of legislation.

We can, and do, make a difference for all women.
