

AAUW California Statement on Racism and Additional Comments

June 12

Over the past two weeks, our country has witnessed an extraordinary outpouring of grief over the deaths of George Floyd and Breonna Taylor at the hands of police. We at AAUW California are not immune from this pain wrought of unfair treatment of our sisters and brothers of color.

We condemn racism and its associated discrimination. It is the root cause of today's injustices. These recent instances of anti-Black violence have reaffirmed the need for major societal change, and for a national discussion going beyond racism and police brutality. Prejudice and inequality - including economic equality - cannot be passively ignored. AAUW has been a leading voice in America in the fight for equity for women and girls, and we especially recognize the additional challenges facing Black women and girls.

AAUW is committed to fighting for justice, and will work collaboratively to give access for all people to the opportunities and resources needed for optimal health and safety. Our organization is a member of the Leadership Conference on Civil and Human Rights, and we will work to advance the policies and systemic changes such as those identified in the New Era of Public Safety: A Guide to Fair, Safe, and Effective Community Policing and Vision for Justice platform.

June 15 – Additional Comments

To our members:

Several days ago, the AAUW California Board of Directors released a statement expressing our strong stance against injustice and anti-Black racism. Some members have taken the time to share their thoughtful reactions, which we appreciate. In response, AAUW California has expanded its earlier statement to further clarify its stance and to address some of the comments we received.

AAUW California values our individual members and welcomes all input. We understand that our members represent a wide range of ideological viewpoints. However, AAUW and AAUW California speak with one voice, and that is the voice of justice for and equal treatment of all persons. This concept is at the core of our Public Policy Priorities. The AAUW vision includes several ideological pillars, one of which is advocacy "to guarantee equality, individual rights, and social justice for a diverse and inclusive society." These policies are developed with input from our members, who also vote on the final statement before it is published. They are also consistent with AAUW National's stand on civil rights: "AAUW advocates for equality, individual rights, and social justice for a diverse society."

To those who feel we have gone beyond our mission statement to promote equity for women and girls, we remind you of the words of Dr. Martin Luther King, Jr.: "Injustice anywhere is a threat to justice everywhere." To those who feel our words were too strong, we remind you of the words of Malala Yousafzai: "I raise up my voice – not so that I can shout, but so those without a voice can be heard." And to those who feel we should not be in the business of condemning police brutality, we remind you of the words of George Floyd: "I can't breathe."

PROGRAMS for 2020-2021

Hi, Everyone! Helen and I are looking forward to some sort of contact with you all at some point or points, depending on this or that regarding COVID 19!

Meanwhile, we know you are dealing with "whatever" comes or goes "whenever" it is clear "whatever is. How's that for a picture of what uncertainty looks like right now?

But we are taking steps to organize the 2020-21 program line-up which in an election year is usually pretty easy because we start off with the League of Women Voters explaining the ballot measures. PH-M is the first local branch this year to contact the League and reserve a date (October 21, which is the third Wednesday). Kay Jones, League program contact, put us on the calendar. However, she added that because the near future is very unclear, the League is actively discussing what format would be used to present the information if they decide to go ahead with a program <u>at all</u> this election cycle. She prefers the traditional format even if it has to be done on Zoom. I was proud to tell her that we are equipped to do Zoom if we have to.

Right now, they are discussing setting up a review of the measures to run on You Tube which might be all the League does. But Kay feels that it would be better to offer both You Tube and Zoom for branches to choose from because setting up a You Tube program would have to be done well in advance of campaign season so last minute changes or information could not be included not to mention that we can ask questions on Zoom but not You Tube.

Anyway, it was a good conversation. So far, we are set for October.....well, sort of.

November is set with a second Wednesday date....Helen Rossi, Deputy Superintendent of the Martinez Unified School District, will tell us about the process of setting up and operating public schools in the time of COVID 19. She's in the middle of organizing it right now so we will get the picture from summer to late fall. She is an outstanding administrator and person so it should be very interesting. Because the third Wednesday is Helen's birthday, she preferred Wednesday, November 11. If there is a problem with that for a number of us, let Helen or Harriett know and we'll find another date.

"Brave Little Nell", the re-enactment of the life of Eleanor Roosevelt, scheduled for March 2020, will be held next spring. Laurie Strawn, who puts on a wonderful biographical presentation according to two Branch members who have seen it, is excited to come in the Spring, so 'date to kum' as newspaper copy editors mark it. And of course, ideas for programs are welcome from members....we got some good ones last year so we're eager for more!

A Note from Zuhal Rahmani, NCCWSL 2016 recipient


Good Morning,

IN MEMORIAM - JEANNE MCGINNIS

Jeanne McGinnis passed away on July 4, 2020. Debbie Byrne sent this letter from her husband, Terry McGinnis, who asked that it be shared with Jeanne's friends.

July 7, 2020

Dear Friends:

It was July 4, 2020 when Jeanne declared her freedom from her world of dementia. Following lunch at her Aegis Memory Care Unit, she moved to the couch in the common area and about an hour later closed her eyes and drew her last breath. There were no signs of pain, struggle, or trauma. Her cause of death is unknown.



The last time I saw Jeanne was June 3rd because the facility was in a Covid-19 lock-down. I knew she would never come home, but Jeanne otherwise was healthy. I expected she would live on for many more years.

In 2015, a few months after her Mom's death at 99, Jeanne was diagnosed with Parkinson's Disease. She was given the standard medications for the disease and they nicely masked the symptoms. Parkinson's is a physical disease.

Sadly in November 2018, Jeanne started showing cognitive problems when we were hit with a couple of small kitchen fires. About 40 percent of Parkinson's people experience mental problems.

From there on, Jeanne stair-stepped down and an ever-increasing slope where she could no longer be cared for at home. She went from having an occasional hallucination or delusion to a situation where they were ongoing. She was running around our block in her underwear, towel, or night gown, knocking on doors, and yelling at people and their kids. It would take up to an hour to get her back into the house.

For about six weeks, our granddaughter (21) helped Jeanne in the morning while I attended to her weekends and the rest of the day. It then became obvious we needed ongoing outside assistance.

Jeanne entered a nearby Memory Care Unit on June 3, 2020. She was severely agitated, uncooperative with her caretakers, and eloped several times, once to a city street. She was placed on 24-hour watch to ensure she would not hurt herself or others.

Thankfully, the Memory Unit at Kaiser stepped into the situation and its doctors and staff were able to calm her down. She was taken off 24-hour watch last week. Kaiser has an outstanding reputation in this area for memory care and we are lucky to have them as a health provider.

I am sorry to share this sad news with you, but you were a part of her circle of friends and I thought you should know.

God is merciful. Please keep her in your thoughts and prayers.

I am doing okay. I have received wonderful support from my children.


